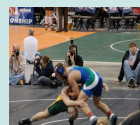

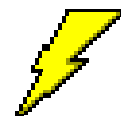

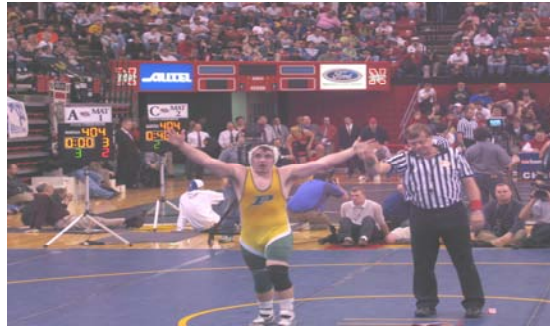
7th and 8th graders are FREE 6-8pm
